## POMEMBNO, SHRANITE ZA PRIHODNJO UPORABO: POZORNO PREBERITE

Če je izdelek že sestavljen, se pred uporabo prepričajte, da so vsi vijaki dobro pritrjeni. Če morate izdelek sestaviti, se ob odprtju paketa prepričajte, da so na voljo vsi elementi, potrebni za sestavljanje izdelka. Če je izdelek poškodovan ali ima napake, ga ne uporabljajte in ga odnesite v najbližjo trgovino.

### 1. SESTAVLJANJE, SKLADIŠČENJE IN PREVOZ

Svetujemo vam, da embalažo izdelka uporabite kot osnovo za sestavljanje, da se izognete morebitnim poškodbam (praskam, luščenju barve, umazaniji itd.). Pred dokončanjem montaže priporočamo tudi, da vijakov ne zategnete preveč in da pustite nekaj prostora za vsako komponento. Po končani montaži se prepričajte, da so vsi vijaki dobro priviti. Ta izdelek je treba postaviti na trdno površino.

Ne pozabite ponovno zategniti pritrjenih elementov dva tedna po sestavljanju in vsaj enkrat na leto.

V primeru daljše neuporabe ali slabega vremena priporočamo, da izdelek shranite v suhem prostoru ali ga ustrezno zaščitite.

### 2. PRIPOROČILA ZA UPORABO

Ta izdelek je namenjen domači in poslovni uporabi na prostem. Izdelek hranite stran od plamena in neposrednih virov toplote, kot so zunanji radiatorji in žari. Pred uporabo preverite, ali so vijaki dobro pritrjeni.

### 3. NEGA IN ČIŠČENJE

Aluminij ima pri zunanjem pohištvu neizpodbitne prednosti. Je zelo lahek in ni podvržen koroziji kot jeklo. Zaradi vsega tega je kakovosten material, ki je kot nalašč za zunanje pohištvo. Jeklo ima koristne mehanske lastnosti in je ne le odporno, temveč ga je mogoče tudi v celoti reciklirati.

Vendar je to material, ki ga je treba zaščititi in vzdrževati, da se na njegovi površini ne pojavi korozija (rja).

Tkanine, uporabljene na izdelkih MATERIAL, so posebej zasnovane in preizkušene za uporabo na prostem.

#### Čiščenje

Pohištvo lahko očistite z neabrazivno gobo. Namočite jo v mešanico milnice z malo belega kisa, s čimer boste očistili površino pohištva, ne da bi spremenili njegovo barvo ali videz.

Da bi se izognili nastanku sledi med sušenjem, vam priporočamo, da takoj po čiščenju posušite z gobasto brisačo.

Če se pojavijo rjasti madeži, na zadevnem območju na izdelku obvezno uporabite posebno sredstvo, da preprečite širjenje rje.

Za tkanine na izdelkih za zaščito pred soncem boste z mokro gobo in šamponom za blazine odstranili trdovratne madeže.

Dosledno upoštevajte priporočila za čiščenje na etiketah tekstilnih izdelkov.

V nobenem primeru na izdelku ne uporabljajte visokotlačnega čistilnika.

### 4. POPRAVILA

V primeru okvare dela izdelka se obrnite na poprodajno službo, ki ima na voljo seznam rezervnih delov za ta izdelek.

## 5. VARNOSTNA NAVODILA

Opozorilo: Nevarnost smrti in nevarnost nesreče za dojenčke in otroke!

Baterije hranite zunaj dosega otrok. Baterij ne puščajte naokrog.

## 6. VARSTVO OKOLJA



Rabljenih električnih izdelkov ne smete odlagati skupaj z gospodinjskimi odpadki. Rabljeni električni izdelki se zbirajo ločeno in jih je treba oddati v zbirnem centru. Za nasvete glede recikliranja se obrnite na lokalne organe ali prodajalca



Baterije in majhne baterije je treba reciklirati ali ustrezno odstraniti. Baterij ne odlagajte v gospodinjske odpadke, komunalne odpadke ali v ogenj, saj lahko iztečejo ali eksplodirajo. Baterij ne odpirajte, ne povzročajte kratkega stika in jih ne poškodujte, saj lahko to povzroči telesne poškodbe.

Izrabljene izdelke je treba oddati v sortiranje agenciji za zbiranje odpadkov.

## 7. GARANCIJA

Za vaš izdelek je na voljo komercialna garancija. Ta garancija dopolnjuje zakonske garancije, ki pripadajo stranki na podlagi zakonodaje, veljavne na območju, na katerem je bil izdelek distribuiran.

Komercialna garancija se začne z datumom nakupa izdelka in velja za obdobje 2 let. Garancija pokriva popravilo ali zamenjavo izdelka po presoji trgovine. Zajema proizvodne napake zaradi manjkajočih komponent in/ali sestavnih delov ter poškodbe, ki nastanejo ob običajnih pogojih uporabe. V tem primeru pošljite svoji trgovini dokazilo o dobavi ali nakupu. Brez tega dokazila bo za vsa dela, ki jih je treba opraviti na izdelku, veljala ponudba, ki jo morate sprejeti, preden se opravi kakršno koli delo. Popravilo ali zamenjava izdelka ne podaljša prvotnega garancijskega obdobja. Vsak zamenjani rezervni del postane last trgovine. Če se izdelek med garancijskim obdobjem ponovno proda, garancija ostane veljavna v korist kupca, ki lahko zahteva uveljavljanje garancije, če predloži originalno dokazilo o dobavi ali nakupu in če so izpolnjeni pogoji za uveljavljanje garancije. Nadaljnja prodaja izdelka ne vpliva na garancijski rok, ki je ostal na dan nadaljnje prodaje.

### Izključitve iz garancije:

Garancija je omejena na vrednost izdelka. Garancija ne velja v primeru običajne obrabe izdelka ali njegovih sestavnih delov, sprememb videza zaradi staranja izdelka, težav, incidentov ali škode, ki so posledica nepravilne ali malomarne uporabe izdelka, neupoštevanja priporočil iz tega priročnika, v primeru naključne škode ali škode, ki je posledica nepravilne uporabe, v primeru škode, ki jo povzročijo zunanji viri, kot so vremenske razmere, v primeru kozmetičnih poškodb, kot so praske, v primeru napake, ki je posledica dogodka zunaj nadzora prodajalca, v primeru kraje izdelka.

## IMPORTANT, TO BE KEPT FOR FUTURE REFERENCE : PLEASE READ CAREFULLY

If the product is already assembled, please make sure that all screws are tightly fixed before using it. If the product requires that you assemble it, please make sure upon opening the package that all the elements needed for setting up the product have been provided. If the product is damaged or has defects, do not use it and take it back to the nearest store.

### 1. ASSEMBLY, STORAGE AND TRANSPORT

We advise you to use the product packaging as an assembly base to avoid any damage (scratches, paint chips, dirt, etc.). Before assembly is complete, we also recommend that you do not overtighten the screws and that you leave some clearance for each component. Once assembly is complete, make sure all the screws are tight. This product should be placed on a stable surface.

Remember to retighten the fixings two weeks after installation and at least once a year.

In the event of prolonged non-use or inclement weather, we recommend that you store your product in a dry place or use a suitable cover to protect it.

### 2. USE RECOMMENDATIONS

This product is intended for home and business use outdoors. Keep the product away from flames and direct sources of heat such as outdoor radiators and barbecues. Check that the screws are securely fastened before use.

### 3. CARE AND CLEANING

Aluminium has undeniable advantages for outdoor furniture. It is very light and is not subject to corrosion like steel. All of which makes it a quality material that's perfect for outdoor furniture. Steel has interesting mechanical properties, it proves to be not only resistant but also fully recyclable.

However, it is a material that requires protection and maintenance to avoid the appearance of corrosion (rust) on its surface.

The fabrics used on NATERIAL products are specially designed and tested for outdoor use.

#### Cleaning

You can clean your furniture with a non-abrasive sponge. Soak it in a mixture of soapy water with a little white vinegar, which will clean the surface of your furniture without altering its color or appearance.

In order to avoid the formation of traces during the drying process, we recommend that you dry with a spongy towel, right after cleaning.

If rust spots appear, be sure to apply a dedicated treatment to the area in question on the product to stop the rust from spreading.

For fabrics on sun sheltering products, a wet sponge and upholstery shampoo will help remove stubborn stains.

Strictly follow the cleaning recommendations on the labels of textile products.

Do not use a high-pressure cleaner on the product under any circumstances.

### 4. REPAIR

In the event of a faulty or broken part, please contact the after-sales service, which has a list of spare parts available for this product.

## 5. SAFETY INSTRUCTIONS

Warning: Danger of death and risk of accident to infants and children!

Keep batteries out of the reach of children. Do not leave the batteries around.

There is a risk of ingestion by children or animals. Seek medical attention immediately if a battery is swallowed.

Never dispose of batteries in fire or water.

Rechargeable batteries must be removed from the product before charging.

Do not mix batteries of different types or new and used batteries.

Avoid high temperatures and humidity during storage and transport.

Storage temperature: -20 'C to +30'C.

## 6. ENVIRONMENTAL PROTECTION



Used electrical products should not be disposed of with household waste. Used electrical products are collected separately and must be disposed of at a collection centre. Contact your local authorities or dealer for recycling advice

## 7. WARRANTY

The commercial warranty starts from the date of purchase of the product and is granted for a period of **2** years.

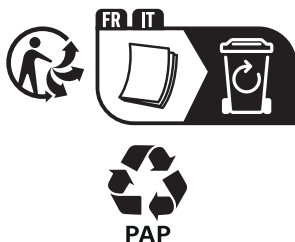
The warranty covers the repair or replacement, at your shop's discretion, of your product. It covers manufacturing defects due to missing parts and/or components as well as damage caused under normal conditions of use. In this case, please send your shop your proof of delivery or purchase. Without this prior production, any work to be carried out on the product will be subject to a quotation which you must accept before any work is carried out. The repair or replacement of your product does not extend the initial warranty period. Any spare part that has been replaced becomes the property of the shop. If the product is resold during the warranty period, the warranty remains valid in favour of the purchaser, who may request that the warranty be invoked provided that the original proof of delivery or purchase is produced and that the conditions for invoking the warranty are met. The resale of the product has no effect on the warranty period remaining at the date of resale.

### Warranty Exclusions :

The warranty is limited to the value of the product. The guarantee is not intended to apply in the event of normal wear and tear of the product or its components, changes in appearance due to ageing of the product, problems, incidents or damage resulting from incorrect or negligent use of the product, failure to comply with the recommendations given in this manual, in the event of accidental damage or damage resulting from improper use, in the event of damage caused by external sources such as the weather, in the event of cosmetic damage such as scratches, in the event of failure caused by an event beyond the control of the seller, in the event of theft of the product.

If the product is used in a country other than that in which it was purchased, your warranty claim may be invalidated. In this case, please contact the retailer in the country of origin where you purchased the Product, who will examine the warranty claim on a case-by-case basis.
